On 28th April 2021, the United Nations passed its firstever Resolution on Global Drowning Prevention in response to deep concern that drowning has been the cause of over 2.5 million preventable deaths in the past decade but has been largely under-recognised relative to its impact. That its importance has been recognised is warmly welcomed and we are committed to achieving all, and more, of the actions within the UN Resolution.

In Western Australia, 2020/21 was the first year of our new Strategic Plan. Highlights include:

- > Successful hosting of the Kimberley Water Safety Forum, engaging with local stakeholders, setting priorities, and inspiring collective action.
- > Bravery Awards ceremony held at the State Reception Centre in Kings Park, the recipients deserve our highest recognition and their actions provide an inspiring example to all.
- Over 15,000 donors and supporters have contributed to the Swim & Survive endowment fund which will provide, in perpetuity, swim lessons to children at risk of missing out.
- > Strengthening the role of our Finance and Audit Committee, and preparations for an investment strategy to responsibly use accumulated funds, to secure our financial future in these uncertain times and to support key strategies.
- > Creating opportunities for regional and remote communities and aligning our lifesaving activities at the local swimming pool with physical activity, education, youth engagement and employment outcomes.
- Maintaining a strong focus on supporting our statewide network of trainers, endorsed swim schools and lifesaving clubs who deliver the vital work of teaching lifesaving skills in their local community.

The Board acknowledges the significant contribution of our five volunteer steering committees and their targeted work to advance;

- 1. our Reconciliation Action Plan,
- 2. inclusion for multicultural communities,
- 3. the sport of lifesaving,
- 4. our financial management and
- 5. the awarding of honours for meritorious service.

At this year's Annual General Meeting we wish farewell to Colin Hassell from the Board. We acknowledge Colin, President and Life Member, and his twenty-two years of service on the Board. For over 50 years Colin has contributed to water safety and drowning prevention initiatives in Australia and the United Kingdom.

His tireless efforts have been predominantly in regional communities, creating opportunities for physical activity, social connectedness and the development of swimming and lifesaving skills, a commitment toward preventing childhood drowning and inclusion of people with disabilities. Colin has demonstrated the most genuine and inspiring example for others to follow and we are all the better for having him in our Society.

Ultimately all our activities are intended to reduce drowning. In 2020/21, 39 people lost their lives to drowning in Western Australia. A more detailed analysis of this statistic highlights:

- Our long-term efforts to reduce toddler and childhood drowning are working, but continued effort is required to empower future generations.
- Reducing drowning among adults is a complex issue and limited progress has been made. New approaches will be required to influence adults' behaviors, particularly while boating and fishing, and to find the right balance between our focus on drowning prevention, while reinforcing the benefits of recreating in and around the water.

Even prior to the COVID-19 pandemic, our guiding approach has been to:

- 1. Lead: Striving to know exactly who is missing out and why people drown.
- **2. Build:** Seeking answers, testing solutions, providing help.
- **3. Empower:** Transitioning our energy and effort into sustainable change.

Over the last 12 months empowering children to safely enjoy the water has been a priority. This year's report highlights our vital work in developing water safety skills throughout the State via our network of members, lifesaving clubs and endorsed swim schools. Their work has resulted in tens of thousands being trained and untold numbers of drownings being prevented through the development of foundation swimming and water safety skills.

Innovation has been at the heart of our efforts. We have strengthened our understanding of what works and uncovered areas where more needs to be done. The challenge we face is to ensure every new generation acquires water safety skills and that vulnerable sectors of our community from multicultural backgrounds, disadvantaged circumstances and regional areas do not miss out.

The outcomes achieved this year would not have been possible without the support of our Principal Community Partner BHP, the WA Government, LotteryWest, Healthway and our sponsors. Royal Life Saving deeply values their ongoing support and contribution.

At a community level, the continued generosity of our supporters, whether that is via a donation, participating in a raffle or purchasing one of our fundraising products, has provided much-needed resources to ensure vulnerable children do not miss out on Swim & Survive lessons.

Included in the report are some comparisons with last year to illustrate how our programs and services have bounced back from COVID-19 restrictions, course cancellations, school and pool closures. For example, last year the total number undertaking our swimming and water safety programs from Infant Aquatics to Bronze Medallion fell to 195,546. It is pleasing to report this year the number returned to pre-COVID levels, recording a total of 236,654 participants.

As a management team we have been focused on ensuring that our returned productivity has not been at the expense of workforce health and wellbeing. An organisation-wide survey was conducted to gather feedback on key indicators such as work engagement, autonomy, fatigue, learning and development.

We have taken steps to foster work-life balance, invested in our teams to build trust and leadership and adapted how we work to improve collaboration and responsiveness across our state-wide workforce. More detail is provided later in this report.

I thank our dedicated members, volunteers, staff and all our committees for their contribution and, in particular, the Royal Life Saving Society WA Board of Directors for their ongoing guidance, stewardship and strategic direction. Finally, to retiring President, Colin Hassell, thank you for your immeasurable contribution to the Society, your leadership and generosity of spirit. You leave an enduring legacy.

> INAUGURAL GOLDFIELDS SPIRIT CARNIVAL 2021

On Friday 26th March 2021 Royal Life Saving WA held its inaugural Goldfields Spirit Swimming and Lifesaving Carnival at the Leinster Town Pool. The carnival was made possible thanks to funding provided by Principal Community Partner BHP and saw around 60 children from Leinster and Leonora take part in swimming races, lifesaving activities and giveaways.

Royal Life Saving WA Senior Manager Swimming and Water Safety Education, Trent Hotchkin, says giving these children an opportunity to take part in these swimming and water safety programs is essential. "Learning to Swim and Survive is a vital life skill that all Western Australian children need to safely participate on, in and around water. Building swimming and water safety skills in young children is vital work and the single most important investment we can make as a community to prevent drowning."

Western Australian drowning data shows that Aboriginal children are 14 times more likely to be involved in a fatal drowning incident than non-Aboriginal children in our state. Overall, half of children who fatally drown are Aboriginal. Many of the children attending the carnival in Leinster come from Aboriginal families in the surrounding towns, so enabling them to engage in the Royal Life Saving Swim and Survive program is an important step as we work to help them build these vital skills and reduce their risk of drowning.

The day enabled the children to come together in a fun environment to participate in an interactive carnival encouraging physical activity and learning valuable lifesaving skills. Mr Hotchkin says the hope is that the children involved in this carnival will make a real difference in the future of their communities.

"By enabling these children to take part in our Swim and Survive swimming and water safety program and enjoy events like the Spirit Carnival we hope to see them lead a generational change, learning skills to become the future lifesavers in remote and regional WA. We want to give these children the opportunity to not only learn skills to keep themselves safe while in, on and around water, but also to equip them to encourage all community members to develop lifesaving swimming skills."

SWIMMING AND WATER SAFETY SKILLS FOR ALL WESTERN AUSTRALIANS

Teaching children personal survival skills is the most important investment the community can make to reduce drowning. In the past year we had a combined 236,654 participants in all our swimming and water safety programs from Infant Aquatics to Bronze Medallion.

This statistic would not have been possible without our state-wide network of 430 local aquatic trainers, 130 endorsed swim schools, 47 Junior Lifeguard and affiliated Pool Lifesaving clubs and the involvement of 935 schools.

The challenge we face is to ensure every new generation acquires water safety skills and that no one misses out. Currently sectors of our community from diverse cultural backgrounds, disadvantaged circumstances and regional areas do not have the opportunity, and we have acted by delivering a total of 159 funded programs, a 27% increase from the previous year.

> KIDSPORT GETS MORE KIDS INTO SWIMMING LESSONS

As part of the State Government's COVID-19 Relief Program, KidSport vouchers became available for families enrolling their children in swimming lessons at registered providers this year. Since the program's inception on 1st January 2021, it has proved extremely successful in getting children back into swimming, with the vouchers used 1,158 times by 30th June 2021, saving families a total of \$168,014!

The KidSport program has been active for a range of sports over the past decade, providing eligible children with grants of up to \$150 per year to help pay club fees, easing the burden on families struggling to fund these activities for their children. Royal Life Saving has provided significant advocacy over recent years, working with the Department of Local Government, Sport and Cultural Industries in calling for these vouchers to also be valid for families enrolling their children in swimming lessons.

Royal Life Saving WA CEO Peter Leaversuch welcomed the changes to the program this year and is pleased to see so many families making use of the vouchers to learn vital swimming and water safety skills. "Royal Life Saving has been concerned that families were finding it difficult to afford lessons and the State Government, with Minister for Sport and Recreation Dr Tony Buti, are to be congratulated for acting to close this gap. Having so many families enrol their children in swimming lessons as part of KidSport in the first half of this year will save lives and help them to develop lifelong skills."

As part of the recent changes to the program families are now able to access these \$150 vouchers twice a year. Royal Life Saving WA has 130 Endorsed Swim Schools across the state and many of these have registered as part of the KidSport program. In fact, nine of the top ten swim schools active in the KidSport program are part of our Endorsed Swim School network!

One of these is the Mandurah Aquatic and Recreation Centre (MARC) where more than 150 students have booked in for swimming lessons this year thanks to the KidSport vouchers. MARC Swim School Supervisor Lindsey Leather says the vouchers have been extremely beneficial.

"Our customers have been thrilled with the opportunity to get their children into lessons they may otherwise have missed due to school swimming cancelations over the COVID lockdowns, among other reasons. By being able to access these vouchers, the kids are learning vital swimming and survival skills which will help them build confidence in the aquatic environment for the future. We are grateful to Royal life Saving WA and the government that swimming lessons have been added to this program."



TRAINING LIFESAVERS AND FIRST RESPONDERS IN EVERY COMMUNITY

Every community needs trained lifesavers, instructors and first responders – to be there to help. Royal Life Saving has developed a comprehensive range of community focused education programs in survival, rescue and first aid as well as specific courses to meet the workforce training needs of the aquatic recreation sector.

Importantly, to ensure all Western Australians have access to this vital community and vocational training, we conducted regional programs that engaged 5,936 participants in locations from remote Kimberley communities to the Great Southern coast. Training was also provided to 357 participants living with a disability, 261 from multicultural backgrounds and 452 Aboriginal Australians.

Aquatic recreation facilities are visited over 10 million times per year and employ an estimated 3,972 lifeguards, swimming teachers, program instructors and pool operators. Key features of the aquatic recreation workforce are:

- 73% of the workforce are female.
- 46% of the workforce are employed casually and most work in a part-time capacity.
- 74% indicate the most enjoyable part is knowing they are making a positive impact on people's lives.

To cover short-term requirements and skill gaps, Royal Life Saving also supplied qualified staff to help aquatic facilities and program providers.

> SWIM TEACHER BY ROYAL LIFE SAVING - SARA DOFASH

Twenty-year-old university student Sara Dofash recently became a swimming instructor and is thoroughly enjoying her new job teaching others vital swimming and water safety skills. Sara is an avid swimmer herself and decided teaching others to enjoy her sport would be a great job while she is studying her double degree in law and human resource management at uni.

"I've always had an affinity to the water, and I enjoy problem solving and working with others. Becoming a swim teacher basically ticked my boxes and called out to me!" she said.

Sara completed the new Swim Teacher by Royal Life Saving course, which provides successful participants with an industry-recognised swim teacher qualification for swimming and water safety instruction.

"I had no formal aquatic experience before the course, just a passion for swimming! I really enjoyed the two-day course. The trainer was well informed and always kept the material interesting. The course itself was very practical, with the majority of the time actually being in the water! I definitely recommend the course for anyone looking to become a swimming instructor. It is very informative and provides a direct pathway for getting your teaching qualifications."

The WA State Government has provided student funding for the Swim Teacher course through its Skills Ready initiative. This was a bonus for Sara who was already on the path to become a swim teacher. "I was eligible for the government funding. It came as a nice surprise because I had actually decided to undertake the training before I found out about the funding."

Sara completed the practical component of the course at Royal Life Saving WA Endorsed Swim School Swim Mechanix Success.

"I enjoyed working with a number of experienced instructors who gave me valuable insight on different teaching styles. The team there was very welcoming and great to work with. I was also able to experience teaching a variety of students, such as adult classes or children with special needs, which was really interesting," said Sara.

Swim Mechanix has since employed Sara as a swim teacher at the school, where she is enjoying her new role. "The facility and the team there is lovely which makes being a swim teacher even more enjoyable."

Drowning remains the leading cause of preventable death in children aged 0–4 years in Australia and toddlers have a greater risk of both fatal and non-fatal drowning than any other age group. Tragically, for every fatal drowning, 13 toddlers are admitted to hospital as a result of a non-fatal drowning incident.

Royal Life Saving is determined to address this crucial issue. We're taking coordinated action by strengthening public awareness of our Keep Watch program and boosting participation in our Infant Aquatics water familiarisation classes. We're also working to ensure home pool owners understand the importance of safe pool use by providing a comprehensive pool barrier assessment service and first aid training opportunities. More recently, we have also provided support for families impacted by toddler drowning through our HELP Grants.

Over the last 10 years fatal toddler drowning rates have halved in WA. This year our health promotion team implemented a new campaign and a number of innovations to raise awareness of our Keep Watch message by:

- Targeting at-risk communities
- Expanding the range of communication channels (media, digital, face-to-face)
- Influencing perceptions and behaviours via hands-on workshops
- Strengthening stakeholder support provided by local governments and the child health network

> NEW KEEP WATCH CAMPAIGN REMINDS PARENTS TO EXPECT THE UNEXPECTED

Royal Life Saving's latest Keep Watch campaign, which was launched in time for summer 2020/21, highlighted the fact that toddlers are curious and unpredictable. It's what we love about them, but it's also the reason parents need to take precautions to keep them safe around water.

Royal Life Saving WA Senior Manager Health Promotion and Research, Lauren Nimmo, says the campaign aims to remind parents and carers about the risks of child drowning. "The risk of drowning triples as soon as a child starts to crawl, peaking shortly after their first birthday, as they start to become more mobile. Curious children are just learning about the world. This is why parents need to keep constant watch. This campaign reminds parents that 'Kids can't help themselves around water, you need to'."

The majority of drowning deaths in toddlers occur in backyard swimming pools (53%), during the summer months (39%). Almost all these deaths were due to a lack of active adult supervision at the time. Miss Nimmo says childhood drowning can happen very quickly. "The reality is that kids are most at risk of drowning during those times when parents aren't expecting them to be around the water. Whether it be a pool, paddling pool, fishpond or dam, it often only takes a few minutes for a curious child to find their way to water while adults are distracted. Having simple safety measures in place can prevent these tragedies from happening."

Kylie Parker knows all too well how quickly a child can find their way to danger. Her three-year-old son Jake tragically drowned in February 2019 after accessing their home pool through a gate that had been accidentally wedged open by a toy.

Kylie says "By the time I realised the gate wasn't closed, it was too late. I'm speaking out to raise awareness of just how quickly and quietly drowning can happen and I urge parents to take supervision and safety of toddlers around water seriously. There are no words that can ever describe how much I love and miss my son every day. If I can save just one child, my son's death won't have been for nothing."

The new Keep Watch campaign urges parents to check their pool fence and gate, empty out paddle pools, buckets and baths and update their CPR skills so they know what to do in an emergency.

Keep Watch Safety Tips:

- > **Supervise.** Actively supervise children around water
- > **Restrict**. Restrict children's access to water
- **Teach.** Teach children water safety skills
- > **Respond.** Learn how to respond in the case of an emergency



CREATING SAFER AQUATIC PLACES AND SPACES

Western Australia is dotted with pools and lakes and crisscrossed with rivers. There is an increased drowning risk when visiting unfamiliar locations and COVID-19 has seen more people seeking out remote places, taking more day trips to isolated rivers or lakes, and holidaying domestically at unfamiliar locations. Not all aquatic environments can be monitored by lifeguards, but all can be made safer: with better guidelines, targeted action in black spots, and greater community awareness of the risks.

Safety in public pools was a key focus. We undertook detailed research to measure the types of injuries and incidents that occur for the 10+ million patrons and established safety benchmarks. Compliance assessments were provided, and risk management plans created. Procedures were tested, signage solutions designed and qualified staff supplied.

> WARMUN CHILDREN LEARN TO RESPECT THE RIVER

12 children from the Warmun Community in WA's Kimberley region enjoyed learning how to stay safe around inland waterways during a 'River Ready' workshop held in December 2020.

River Ready is a water safety education course that focuses on the challenges and conditions of inland waterways such as rivers, lakes and dams. The program is part of Royal Life Saving's Respect the River initiative, which aims to equip people with the skills and knowledge to safely enjoy WA's extensive network of beautiful inland waterways.

The course was delivered by Warmun Remote Aboriginal Swimming Pool Manager Stephen Waterman, who wanted to run the program for the local kids during the school holidays to help prepare them for Warmun's wet season. The course took place at local spot Winnepa Springs, which offered a practical, real-world environment for the kids to work on their newly acquired skills.

For the Warmun children the program was very timely, as a local boy, 14-year-old Frank, was swept away by the fast-flowing Turkey Creek on the first day of rain the previous year. Thankfully he managed to grab onto a tree branch, where he clung for dear life until his uncle, who got word of what happened, found Frank, and pulled him out of the water.

Stephen Waterman says it would have been an incredibly difficult experience.

"I don't know if you could imagine the sheer terror this young man would have felt," said Steve. "Believing he was going to die, all alone, and no one was going to find him. I had to make sure these kids learnt skills to stay safe should any of them face a similar situation again!"

The Kimberley region has one of the highest inland waterway drowning rates in the state. Programs such as River Ready help to provide vital water safety skills to people in our most at-risk communities, particularly in regional and remote Western Australia.

PROMOTING SAFE PARTICIPATION AND BEHAVIOURS

Royal Life Saving has developed a range of innovative safety messages to reach key audiences. In 2020/21 we made it easier for people to access this vital information by incorporating interactive content including videos, how-to information, news and interviews.

We have broadened the range of channels (media, digital, face-to-face) in order to reach our target audiences and built specific programs to:

- Motivate multicultural communities to enrol in swimming lessons.
- Improve parental supervision at public pools.
- Increase the adoption of lifejacket use.
- Reduce the number of alcohol related drowning deaths and injuries.
- Influence the perceptions/behaviours of people over 65.

Importantly we undertook research to identify problems, inform policy and improve practice. We campaigned to influence policy makers and other key decision makers on what is needed to prevent drowning, and also hosted workshops and attended events throughout Western Australia.

> JOONDALUP OVER 55s LAP UP NEW WATER SAFETY SKILLS

More than half of those who drowned in Western Australia in 2020-21 were aged 55 and over, and as our population continues to age this figure is likely to increase further in the years to come. In order to tackle this growing issue Royal Life Saving WA launched the Aqua Skills 55+ program, teaching those aged over 55 vital swimming and lifesaving skills to stay safe around the water.

The course is structured as a four-week refresher suitable for people of all abilities, and provides skills to deal with emergency situations, personal survival techniques and a thorough understanding of water safety knowledge to reduce the likelihood of drowning. It's a great way to meet new people, learn new skills and have fun!

The new course was held for the first time at the Joondalup Arena in May 2021, with 24 people attending and having a great time! The course was run by Royal Life Saving WA Community Trainer Isabel Franzoni, who is very experienced in teaching courses for older adults and makes those attending feel comfortable and confident in the water.

Participants first completed a session of resuscitation and out of water skills before then taking on three inwater sessions. Caroline, who attended the Joondalup program, says it was a real eye-opener for her.

"Before the course I thought I could save my grandchild if they were drowning but I learned that in reality I actually wouldn't have been able to."

Throughout the four weeks some strong friendships were formed, and participants showed great camaraderie as they completed each activity, encouraging each other along the way. They even presented Isabel with a thank you award and flowers at the end of the course for the amazing work she did teaching them such important skills. The Aqua Skills 55+program is run across Perth and is currently FREE for individuals over 55 years.

> INAUGURAL KIMBERLEY WATER SAFETY FORUM

Over the past decade, the Kimberley has recorded the second highest drowning rate of any WA region. In total, 51 drowning incidents have been recorded in the Kimberley over that period with 20 people losing their lives. The majority of these incidents happened at inland waterways such as rivers and lakes, and men are three times more likely to drown than women.

This presents a unique challenge for water safety authorities in the region. Royal Life Saving WA worked with local community members to discover what more can be done to prevent drowning across the Kimberley, through the inaugural Kimberley Water Safety Forum.

The Forum, held at the Oaks Hotel Broome on Thursday 13th May 2021, was a chance to bring together over 30 key stakeholders and community members with an interest in water safety to share their experiences and discuss key local drowning prevention priorities and actions to address the high drowning rates in the region. Those attending also had the opportunity to learn more about trends in drowning within the local community, current challenges facing the Kimberley and to assist in the development of a water safety strategy for the region.

The day opened with a welcome to country smoking ceremony with Dianne Appleby from Nyanja Buru Yawuru, followed by presentations from key organisations including the Department of Education, Department of Local Government, Sport and Cultural Industries, Australian Water Safety Council, Garnduwa, Curtin University, and Royal Life Saving.

Royal Life Saving WA Kimberley Development Officer Glenn Taylor says the forum was an important opportunity to address a significant issue. "WA's regional areas continue to be over-represented in drowning deaths, with a drowning rate 3.7 times higher than the Perth metro area. Local understanding of this serious and preventable issue is crucial."

"I'm very heavily involved in the swimming community of the Kimberley, and people up here spend a lot of time in the water, it's a big part of our life. My goal in working with Royal Life Saving is to decrease the drowning rate in our community, so it was great to hear important local perspectives from Kimberley residents and experts to enable us to begin to develop a solution."



Outstanding acts of bravery were recognised at a ceremony held in October 2020 at the State Reception Centre Kings Park. The awards recognised individuals who have gone to the aid of someone in distress, sometimes at risk to themselves, who have shown initiative in rescuing someone from the water and outstanding efforts in providing emergency care to those who have been injured.

To mark the significance of the occasion, those in attendance included the Honourable Kim Beazley AC. Governor of Western Australia, members of parliament, local representatives and Life Members of the Royal Life Saving Society.

Separate presentation events were also held in Port Hedland, Broome, Derby and Rockingham to recognise those award recipients who could not attend the presentation ceremony.

In total, 68 individuals were honoured for their outstanding acts. Everyone displayed exceptional courage, empathy and initiative by applying lifesaving skills in emergency situations, sometimes at risk to themselves, and deserve our highest recognition.

> Hero Couple Awarded For Rockingham Jetty Rescue

A Rockingham couple received Royal Life Saving Bravery Awards for rescuing a man at the Palm Beach Jetty. A relaxing trip to walk their dog didn't go guite as planned for Joanne White and Ben Cox on a cold morning in August 2020, when they ended up rescuing Allan Godley following a sudden medical incident.

Allan was visiting the jetty to sail his remote-control yacht and says initially all was smooth sailing. "Ben and Jo put their heads over the handrail and started chatting to me about the boat. The last thing I remember is Ben asking 'what sort of range can you get with that?' and I remember replying that I wasn't too sure because I didn't want to risk losing it!" Soon after the conversation ended Joanne heard a splash. Allan had suffered a seizure and fallen into the water, hitting his head on the railing on the way down.

Joanne responded immediately. "I ran down to save him, got into the water, and hoisted him up onto my shoulders, pushing him up so that another man could pull him out of the water." While Joanne raced into the water Ben called Triple Zero and alerted other bystanders so they could also help. Allan says his seizure came with no warning and he will be forever grateful to Joanne and Ben for saving his life. "I am as thankful as you could get, if it was not for them, I would not be here today as nobody else would have seen me. Jo said another 10 seconds and I was a goner."

Following the incident Allan discovered he had a brain tumour which he has since begun treatment for. After removing Allan from the water Joanne placed him in the recovery position and she and Ben monitored him until emergency services arrived. Joanne says she would recommend that everyone have aquatic rescue training, as it certainly prepared her to save Allan's life.

For their selfless and immediate actions Joanne received a Gold Medallion and Ben a Gold Star Royal Life Saving Bravery Award, with many family and friends attending the presentation to congratulate them. For Ben the Gold Star will join an array of other medals he has received in his life so far, including an Olympic Gold Medal for basketball at the 1996 Atlanta Paralympic Games, and an Order of Australia Medal which followed that achievement!

Their Bravery Awards were presented by City of Rockingham Mayor Barry Sammels at the Palm Beach Jetty where the incident took place, while they were also later congratulated by Premier Mark McGowan who took time out to personally congratulate them for their incredible rescue.

At the end of the day the top three teams were: HBF Arena Team 1 in third place, Beatty Park Team 2 in second place, while Rebecca Brook, Courtney Foster, Rachel Southam and Mhari Wilson from Armadale Fitness and Aquatic Centre Team 1 took out first place!

Royal Life Saving Society WA would like to congratulate all the competing teams for their performances this year and we look forward to seeing each of them return in 2022. We'd also like to thank the Leisure Institute of WA Aquatics for their continued support of the Pool Lifeguard Challenge, an invaluable event which ensures the continued development of lifeguarding in WA.

We hope all competitors returned to their centres with a new sense of the importance of the role they play in keeping aquatic centre patrons safe.





The Directors present the financial report of The Royal Life Saving Society Western Australia Inc (RLSSWA) for the year ended 30th June, 2021.

DIRECTORS

The name of directors in office any time during or since the end of the financial year:

Colin Hassell (1999 – Present)

Colin became a member of the Royal Life Saving Society UK at 12 years of age, before becoming a volunteer lifeguard at 18, patrolling inland waterways following a spike in local drownings. Emigrating to Western Australia in 1986, Colin managed several aquatic centres across metro Perth and regional WA. With extensive aquatic industry experience he was invited to join the Royal Life Saving WA board in 1999, and named President in 2017. He believes firmly in Royal Life Saving's vision to reduce, and even eradicate drowning across Australia.

David Cummins (2007 - Present)

With over 40 years' involvement in the aquatics industry David served as President of Masters Swimming WA from 1987-1992, has been a member of Masters Swimming Australia's Board for 20 years, served as Chairman of the 1999 Pan Pacific Masters Swimming Championships, has chaired many State, National and Masters Games Championships and held positions with local swimming clubs. He was appointed to the board of Royal Life Saving WA in 2007 and named a Life Member of Royal Life Saving WA in 2018.

Mark Gubanyi (2014-October 2020)

Following the drowning death of his four-year-old daughter Kaitlin in 1999, Mark became an Ambassador for the Keep Watch toddler drowning prevention program and a vocal advocate for drowning prevention. In October 2014 Mark became a member of the Royal Life Saving WA Board of Directors. He has received the RLSSWA Lifetime Achievement Award, WA Meritorious Service Order and is a National Fellow Member of Royal Life Saving Society Australia. His hope is that through community awareness we can achieve zero toddler drownings across the nation.

Carol Harper (2015 - Present)

Carol has worked in the Swimming Pool industry for over 25 years and is currently an Independent Consultant and Project Manager in residential aquatics. Carol has extensive knowledge and networks in outdoor living in WA, and won more than 50 industry awards with Exclusive Pools. She hopes to make a positive impact through her work with Royal Life Saving WA as the Society aims to prevent drowning in our community. Carol believes it is vitally important to learn First Aid and resuscitation skills so that everyone can be a lifesaver.

Kathleen Lowry (2017 - Present)

Kathleen holds a Masters of Business and is currently the Director of the Conservation and Parks Commission. Previously Kathleen managed the recreation branch at the former Department of Sport and Recreation and worked with LIWA Aquatics and RLSSWA on strategic development and funding opportunities. Kathleen has led state strategic planning processes for communities to access recreation facilities and remove barriers. Her varied background and passion for community development led Kathleen to become a Board Member of the RLSSWA.

Vaughan Davies (2017 - Present)

Vaughan grew up in regional WA and started his working life as a casual pool lifeguard. He spent 10 years in local government overseeing the management and construction of swimming pools across regional Australia, before becoming regional manager of Tourism WA in Broome. He then joined the Department of Aboriginal Affairs where he became the Director General in 2016. Vaughan is currently Assistant Director General of the Heritage and Property Division at the Department of Planning, Lands and Heritage. Impressed by RLSSWA's Remote Aboriginal Swimming Pools program in regional WA, he joined the board's Aboriginal Reference Group in 2017.

Justine Leavy BSc, MPH, PhD (2018 - Present)

Justine completed a PhD from UWA in 2014, where she holds a Masters in Public Health, and Bachelor of Science (Health Promotion) from Curtin University. She currently works at Curtin University's School of Population Health. In 2019 she launched the Western Australian Drowning Prevention and Water Safety Evaluation and Research Network (WADER-n). She is an active drowning prevention researcher, and a member of the International Drowning Research Alliance (IDRA). Justine joined the board of RLSSWA in 2018 to bring her expertise and provide strategic advice to the Directors about research and evaluation pertinent to drowning prevention.

Aaron Brinkworth (October 2020 - Present)

Aaron has worked in the bio-pharmaceutical industry for the past 25 years, with experience establishing sales & distribution networks across the Asia Pacific region. Some of this work has focussed on advancing public health for at-risk populations globally. He has also been an active Surf Lifesaver since 1983, has experience teaching VacSwim and was also employed as a City of Stirling Lifeguard in the late 1980s. His role as part of Royal Life Saving WA's board of directors enables Aaron to fulfil his desire to contribute to the broader community in our state.

Gningala Yarran-Mark (October 2020 – May 2021)

Gningala was Royal Life Saving WA's first female Aboriginal Director in its more than 100-year history. She completed a Bachelor of Laws from UWA in 2002 and holds a Master of Business Leadership from the Curtin Graduate School of Business (2016). She currently works at United Group Limited (UGL) delivering KPI's contained in the company's Reconciliation Action Plan. Gningala contributed to the development of RLSSWA's REFLECT – Reconciliation Action Plan and has driven action via our Aboriginal Steering Group. She is committed to helping RLSSWA actively seek opportunities to engage with Aboriginal and Torres Strait Islander people.

PRINCIPAL ACTIVITIES

During the course of the year the principal activities of RLSSWA were to empower the community to be safe when in, on or around water and to lead efforts to reduce the impact of drowning. Principal activities include:

- Delivery of programs that increase the number of Western Australians with water safety, swimming, survival and rescue skills.
- Training of lifesavers and first responders in every local community.
- Eliminating toddler drowning.
- Creating safer aquatic places and spaces.
- Provision of support for victims and families impacted by a drowning incident.
- Increasing public awareness and community support.

SIGNIFICANT CHANGES

No significant changes in the nature of these activities occurred during the year.

OPERATING RESULT

The surplus after providing for income tax for the 2021 financial year amounted to \$721,131.

AFTER BALANCE DATE EVENTS

No matter or circumstances have arisen since the end of the financial year which significantly affected or may significantly affect the operations of the entity, the results of those operations or the state of affairs of the entity in future financial years.

CORONAVIRUS (COVID-19) PANDEMIC

The COVID-19 outbreak was declared a pandemic by the World Health Organisation in March 2020. The outbreak and the response of Governments in dealing with the pandemic is interfering with general activity levels within the community and the economy. A COVID-19 management plan was implemented immediately including additional hygiene measures and physical distancing. Whilst there have been disruptions to the supply chain these have been addressed by forward planning and seeking alternate sources to minimise the impact on the business.

The situation is unprecedented, and management continues to consider the potential implications of COVID-19, which may include disruptions to the supply chain, availability of employees and changes to customer demand. However, as at the date these financial statements were authorised, the association was not aware of any material adverse effects on the financial statements or future results as a result of the COVID-19.

NOTES TO THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 30TH JUNE 2021

NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

These financial reports are special purpose financial reports prepared for the members in order to satisfy the accounts preparation requirements of the Associations Incorporations Act 2015 and the Royal Life Saving Society Western Australia Inc (RLSSWA) constitutional reporting requirements. The Directors' have determined that RLSSWA is not a reporting entity. The AASB Standards adopted are;

AASB 101 **Presentation of Financial Statements**

AASB 107 Statement of Cash Flows

Accounting Policies, Changes in Accounting Estimates AASB 108

AASB 1031

Interpretation of Standards **AASB 1048**

AASB 1054 Australian Additional Disclosures

AASB 9 Financial Instruments

The following specific accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this report.

Reporting Basis and Conventions

The financial reports have been prepared on an accruals basis. They are based on historic costs and do not take into account changing money values, or, except where specifically stated, current valuations of non-current assets.

RLSSWA is exempt from income tax under the definition in S11-5 and S50-5 of the Income Tax Assessment Act 1997 as amended. Consequently "tax effect accounting" is not taken into account in the preparation of the financial report. RLSSWA has been endorsed by the Australian Taxation Office as an Income Tax Exempt Charity (ITEC), Public Benevolent Institution (PBI) and Deductible Gift Recipient (DGR).

(b) Revenue Recognition

Grants/Government Funding and Sponsorship Income: Government contributions and sponsorship income is recognised as income as the funds are being expended on the relevant projects. RLSSWA does not recognise Government contributions as income when they are received or receivable in accordance with AASB 1004, but rather, continues to match the income with related expenses as and when they are incurred. As a special purpose reporting entity RLSSWA is able to choose this option.

Interest Income: Interest income is recognised as it accrues.

Trading and Fundraising Income: Revenue under this category is recognised as it is received or accrued.

(c) Income Received in Advance

Income Received in Advance is carried forward to the extent that it is to be earned in a future period and does not relate to expenditure which has already been brought to account.

Receivables to be settled within 30-60 days are carried at amounts due. The collectability of debts is assessed at balance date and specific provision is made for any doubtful accounts.

(e) Non-Current Assets

The carrying amounts of all Non-Current Assets are reviewed to determine whether they are in excess of their recoverable amount at balance date. If the carrying amount of a Non-Current Asset exceeds the recoverable amount, the asset is written down to the lower amount.

Cash and Cash Equivalents include cash on hand and deposits held at call with banks at normal commercial rates, policies and terms regularly adopted by businesses in Australia.

Inventories are measured at the lower of cost and current replacement cost. Inventories acquired at no cost, or for nominal consideration, are valued at the current replacement cost as at the date of acquisition.

(h) Depreciation of Property, Plant and Equipment

Depreciation, where applicable, has been charged in the accounts on property, plant and equipment, and motor vehicles, so as to write off each asset over the estimated useful life of the asset concerned. All fixed assets are depreciated on the straight-line basis over their estimated useful lives as follows:

Class of Fixed Asset **Depreciation Rate** Buildings 6% Furniture & Fittings 25%

12.5% - 25% Plant & Equipment Motor Vehicles 12.5% Website Development

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are recognised immediately in profit or loss.

Right-of-use assets are measured at cost, which is the present value of future lease payments. Lease assets are depreciated using the straight-line method over the lease term. Lease liabilities are initially measured at the present value of future lease payments discounted using the Association's incremental borrowing rate.

(i) Amortisation of Building

Leasehold buildings are measured on the fair value basis, being the amount for which an asset could be exchanged between knowledgeable willing parties in an arm's length transaction. An independent valuation was performed on the 30 June 2020.

RLSSWA provides for its Long Service Leave liability in respect of all employees with service in excess of five years. As RLSSWA is not legally bound to provide for long service leave until the employees' service exceeds ten years (subject to ill health etc.), RLSSWA's policy is to phase in its provision for Long Service Leave during the five to ten year period of service. Annual leave has been provided for in the financial report on the basis of employee's accumulated net entitlements at year end.

(l) Accounts Payable

Liabilities are recognised for amounts to be paid in the future for goods or services received, whether or not billed.

(m) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of the expense of the item. Receivables and Payables in the Statement of Financial Position are stated with the amount of the GST included. The net amount of GST recoverable from, or payable to, the ATO, is included as a Current Asset or Current Liability in the Statement of Financial Position.

(n) Contingent Liabilities and Contingent Assets

Contingent Liabilities and Assets are not recognised in the Statement of Financial Position but are discussed in the relevant schedules and notes, where applicable. They may arise from uncertainty as to the existence of a liability or asset, or represent an existing liability or asset in respect of which settlement is not probable or the amount cannot be reliably measured. Remote contingencies are part of this disclosure. Where settlement becomes probable, a liability or asset is recognised. A liability or asset is recognised when its existence is confirmed by a future event, settlement becomes probable (virtually certain for assets) or reliable measurement becomes possible.

RLSSWA holds numerous trophies which have been purchased or donated. All are of a perpetual nature. The value of the trophies is indeterminable due to their nature therefore, have not been included on the RLSSWA Statement of Financial Position.
