Endorsement Requirement

The following 3 requirements must be maintained as a minimum standard for the Swim School operation:

- 1. Use of the Swim and Survive course curriculum (Swim & Survive Certificates).
- 2. Nationally certified instructor proficiency as a minimum standard for qualification (RLSSWA Swim Teacher or equivalent). Instructors must also undertake an in-house Swim School induction in resuscitation and rescue (or preferably hold a current qualification in both).
- 3. Instructor/ pupil ratios set at or below these maximum ratios in accordance with the RLSSA Guidelines for Safe Pool Operation:

Stages	Ratio
1 to 3	1:10
4 to 6	1:12
7 to 16	1:15

By maintaining these standards as a minimum, the Swim School will provide the customer with recognised best practice for swimming and water safety lessons.

Maintaining Endorsement

- RLSSWA will regularly review your Swim School to assist in maintaining the standards for endorsement.
- The Swim School will operate a system of currency to ensure staff qualifications are maintained, instructor/pupil ratios are met, and RLSSWA course curriculum is utilised.
- Provide participant statistics on a quarterly basis to RLSSWA head office for reporting purposes.

- RLSSWA will promote the Swim School through its channels of promotion and refer customers to the swim school.
- RLSSWA will advocate and promote the importance of swimming, water safety and lifesaving to the community.
- RLSSWA will research and communicate swimming and water safety education information.

RLSSWA Membership

RLSSWA is a member-based organisation that is committed to developing its membership program and the recognition of its members. Membership is open to any person or organisation who wishes to further the interests of the RLSSWA and to further the work and objectives of the society. On successful completion of the RLSSWA Endorsed Swim School paperwork your Swim School will also become an affiliated member of RLSSWA.
