

## **Keep Watch Online Survey – Terms and Conditions**

1. Instructions on how to enter and other details contained within promotional advertisements for this competition form part of the conditions of entry.
2. By entering the competition, entrants agree to abide by these Terms and Conditions.
3. The Terms and Conditions of this competition are governed by the laws of the State of Western Australia.
4. The competition is being run by Royal Life Saving Society WA, McGillivray Road, Mt Claremont WA 6010.
5. The Keep Watch Online Survey (“the competition”) commences at 9.00 am Australian Western Standard Time (AWST) on 01/02/2019
6. The closing time for entering the competition is 5.00pm AWST on 15/03/2019.
7. Entry to the competition is limited to people currently residing in Western Australia who are a parent, carer or grandparent of children aged 0-4 years
8. To enter the competition, the entrant must:
  - (a) not be a Royal Life Saving Society WA staff member or a family member of a Royal Life Saving Society WA staff member; and
  - (b) fill in the feedback survey through an online survey platform and submit the survey before the closing time
9. Entry to the competition is free. Entrants will be responsible for all costs associated with entering the competition, which may include costs associated with accessing the internet.
10. Entrants may only enter the competition once.
11. Staff employed by Royal Life Saving Society WA and their immediate family members are not eligible to enter the competition.
12. There will be four (4) prizes. This includes one (1) early bird prize and three (3) standard prizes.
13. The early bird prize will be one (1) x \$100 Coles Myer gift card. Entrants who complete the survey by 15/02/2019 will be eligible for entry to the early bird prize draw.
14. There will be one (1) draw for the early bird prize on 18/02/2019 at 9.00am Australian Western Standard Time at The Royal Life Saving Society WA head office.
15. The three (3) standard prizes will be \$100 Coles Myer gift cards.
16. There will be one (1) draw for the standard prizes at 9.00am Australian Western Standard Time on 18/03/2019 at The Royal Life Saving Society WA head office. Prize winners will be drawn at random.
17. The prize winner will be contacted within seven (7) days of the draw by the phone number supplied by the entrant on the online survey.
18. If the prize winner does not respond to claim the prize within twenty-one (21) days of the draw, a re-draw will be conducted within thirty (30) days of the original draw date, in the same location, and with the same method. Redraws will continue in the same manner until all prizes have been claimed by prize winners.
19. If the prize winner is under the age of 18 years, the prize will be awarded to the winner’s parent or legal guardian.
20. The prize may be collected in person by the prize winner or parent/legal guardian or may be mailed/couriered.
